### Narrative

ON THE ABOVE DATE AND TIME, WHILE MAKING A ROUND ON 3 MAIN RIGHT SIDE, AN INMATE APPROACHED ME AND ASKED ME IN A LOUD VOICE, "WHAT THE FUCK IS UP WITH THE T.V." AT THIS POINT I ASKED OFF. DOUGLAS ABOUT THE T.V. AND HE STATED THAT THE TELEVISION WAS OFF BASED ON THE FACT ONE INMATE HAD NOT COME UP FOR ROLL CALL. AT THIS POINT THE INMATE LOOKED AT ME AND STATED, "WHO THE FUCK DO YOU THINK YOU ARE?" AT THIS POINT I WALKED TO 3 MARSHALL AND CALLED FOR OFFICERS TO RESPOND SO THAT THIS INMATE COULD BE TRANSFERRED TO THE BULLPEN. WHEN OFF. TANGORRA WITH HIS K-9 ARRIVED I PROCEEDED TO DORM 3-3 WITH SGT. CONDATORE, SGT. ALVAREZ, OFF. DOUGLASS, OFF. COOK, OFF. SANKAR OFF. PARISI, OFF. KITCHELL, AND OFF. YAGAN.

AT THIS POINT WE ENTERED DORM 3-3. UPON ENTERING THE DORM INMATE ROSENDO LEWIS-OROPESA (9-29-75) IMMEDIATELY WALKED TOWARD ME. AT THIS POINT I GRABBED THE INMATE BY THE BACK OF HIS SHIRT AND ESCORTED HIM OUT TO THE CORRIDOR. WHILE OUTSIDE I ORDERED HIM TO FACE THE WALL AND BE QUIET. INMATE IMMEDIATELY TURNED ~~TOWARD ME AND SAID~~ "WHO THE FUCK DO YOU THINK YOU ARE?" AND RAISED HIS RIGHT AND WITH A CLENCHED FIST. AT THIS POINT I GRABBED THE FRONT OF THE INMATE'S SHIRT WITH BOTH HANDS AND PULLED HIM TO THE GROUND. THE INMATE STARTED KICKING AND SWINGING HIS ARMS. AT THIS POINT THE INMATE ATTEMPTED TO GET UP WHEN K-9 OFFICER TANGORRA STEPPED IN WITH HIS K-9. THE K-9 BIT THE INMATE ON HIS LEFT FORE-ARM. THE INMATE STILL CONTINUED TO STRUGGLE BUT WAS RESTRAINED AND HAND-CUFFED BY SGT. CONDATORE WITH OFFICERS DOUGLASS AND KITCHELL. INMATE WAS THEN ESCORTED TO THE MEDICAL DEPARTMENT WHERE HE WAS TREATED BY NURSE JOCELYN CRUZ. PHOTOS OF THE BITE WOUND WERE TAKEN BY SGT. (TROMBETTA) AT 8:55 A.M. INMATE WAS TRANSPORTED TO BARNERT HOSPITAL E.R. FOR TREATMENT TO THE WOUND. END OF REPORT.

*NURSE S. CRUZ SAW IN LEWIS-ROSENDO (9-29-75) IN MED. DEPT. NOTED BITE WOUND IN (L) ARM & BITE MARK IN (L) THIGH (-) FOR DEPT WOUND. CHLORASEPT & I.D.S.G. WAS DOUB. SENT TO ER FOR TX & EVAL. NO OTHER MED.*
