Q1. Generally speaking, do you believe there is or is not discrimination against (Respondent's own group identity) in America today?

Group	Percent of each group saying discrimination against their own group exists in America today
African Americans	92%
Latinos	78%
Native Americans	75%
Asian Americans	61%
Whites (Non-Hispanic)	55%
LGBTQ	90%

Example interpretation: “Overall, 78% of Latinos say that discrimination against Latinos exists in America today.”

Example interpretation: “Among Latinos who believe discrimination against Latinos exists in America today, 47% say the larger problem is discrimination based in the prejudice of individual people. Thirty-seven percent of Latinos who believe anti-Latino discrimination exists say that discriminated based on laws and government policies in the larger problem, and 14% say both equally are a problem.”

Data for Q13, Q15, and Q23 (whites only)

Asked of: Respondents in random half sample A who have ever applied for a job

Q13. What about you? Do you believe you have ever personally experienced discrimination because you are white when applying for jobs?

Asked of: Respondents in random half sample A who have ever been employed

Q15. What about you? Do you believe you have ever personally experienced discrimination because you are white when it comes to being paid equally or considered for promotions?

Asked of: Respondents in random half sample B who have ever applied to or attended college for any amount of time

Q23. What about you? Do you believe you have ever personally experienced discrimination because you are white when applying to or while at college?

Table Z:
Percent of White Americans Saying They Have Been
Personally Discriminated Against Because They Are White In Each Situation

Situation	Percent of whites saying they have been personally discriminated against because they are white in each situation
When applying for jobs	19%
When being paid equally or considered for promotions	13%
When applying to or while at college	11%

Example interpretation: Among all whites who have ever applied to or attended college, 11% say they've been discriminated against because they are white.
